Minutes Annual Meeting

Glyndon Lutheran Church, Minutes of Annual Meeting, January 26th 2014

- 1. President Jeff Wallin announced a quorum (50 members present) and called the meeting to order.
- 2. Devotions were led along with an opening prayer
- **3. Secretary's report:** Motion was made to accept report, seconded and carried.
- **4. Treasurer's report:** Motion was made to accept report, seconded and carried.
- 5. Treasurer's report:
 - 2013 budget shows a loss. Jeff explained this doesn't always show a clear picture
 - Budget was actually a wash.
 - General fund for 2014 is behind because of 3 storm cancellations.
 - No other discussion

6. Other report:

Pastor's, Family Minister, President's letter, Circles, & Food Pantry
 **It was chosen to review these on the member's own time and contact the council with questions.

7. New Business

- **Sunday school budget** was discussed by Kris and Leroy Babolian. Wednesday nights has over 30 kids for 2 hours.
- Some bills are lumped together on the budget- books and videos will be used again. Microsoft provides designated funds of approximately \$2000.00 so most the \$2500.00 expense was covered.
- Pat Myhre addressed the Pastor's report of a possible screen projector. Questions were: How would we use it? Possible uses would be education, worship for videos and projecting song lyrics. No cost of the project was available at this time.

• Buildings and properties:

It was questioned why there was no funds budgeted for the repair and replacement of the stained glass windows. Leroy B. explained that the insurance covered the balance due.

- **Items for future assessment- replacing all windows. Education wing leak and are hard to clean.
- ** Vestibule on the North side is cracking and falling apart. Needs to be removed and replaced. This motion was made by Don Lein and seconded by Monte Olson. Motion carried.
- **Sidewalk in front of church needs to be replaced- This is a City sidewalk. Estimate will be turned into the City.

Staff Salaries

- ** Pastor's salary has been reduced due to her request to be changed to ¾ time.
- ** Kris will remain at $\frac{3}{2}$ time with the synod picking up \$1000.00 for reimbursement of her time.

An increase to \$1200.00 has been requested. Kris continues to work on her rostering process.

- ** It was requested that a reimbursement be made to repay student loans for staff.
- ** Office manager will remain part time with an average of 16 hours per week.
- It was discussed to put together a finance committee to oversee the church business. Motion made by Leroy Babolian, Second Gordon Wyland. Motion carried.
- Lois Bekkerus brought up discussion about a new church directory. Council will look into this project. Motion made by Lois B and seconded by Marissa Blair. Motions carried.
- 8. Motion was made to approve budget by Roger Wyland, Second by Deb Tollefson. Motion carried.
- **9.** Elections: Vote to add all 4 at large members. Motion to accept all made by Darlene Sandal, Second Don Lein. Motion carried.

Family Minister's Report

When I was a senior in college my friend joked that I had an entire hat rack for all the different hats (various relationships) that we had between us; we were roommates, I was going to be the Maid of Honor in her wedding, and she was my supervisor in my Admissions Office job. We were able to "wear the different hats" just fine because we named them and respected each other in each role. I was reminded of the "hat rack" when reflecting on the past year; I wore many hats in 2014.

My Glyndon Lutheran hat(s) have been the ones that I have worn the most.

I continue to be part worship, assisting Pastor Jeni and hosting while Pastor Jeni was gone. I preached a few times and led the Children's Christmas program. I also preached at the Peterson/Fish wedding.

Faith Formation is the hat that I wore the most; I meet with the three year olds - 4th graders meet on Sunday mornings and Wednesday (shortened) educational time before worship.

The 5th and 6th graders meet after school on Wednesdays diving into the Biblical narrative. And I also led the 5th graders in their 4 week First Communion preparation.

The 7th and 8th graders meet after worship on Wednesdays; I prepared the lesson plans in the winter and spring of this past year with the focus on the Lord's Prayer. This fall I assisted Pastor Jeni walking with them through the 10 Commandments. I also plan and execute the Servant Events for the 7th and 8th graders. We added a trip to the Twin Cities to pack meals at Feed My Starving Children and go to ValleyScare.

Pastor Jeni and I met with the 9th graders for lunch on Thursdays last spring and this fall I met with many of them as 10th graders to help them write their Faith Stories in preparation for their Affirmation of Faith Service, which was October 26th.

This school year I have been working with Pastor Jeni walking the 9th graders through the Apostle's Creed during lunch on Thursdays where they eat and have faith filled conversations. This school year we have added 11th and 12th grade Peer Ministers who attended a training to lead the small groups.

I enjoy taking part of Stewardship Work Days and I also attended the Women's Retreat in July.

The summer of 2014 had many fun adventures. We had Pathways Staff come and lead Day Camp with the Elementary aged young people; this year we shared Day Camp with Dilworth Lutheran. I also led two summer trips. The first was a Servant Trip to the Jamaica area of Queens, NY; Glyndon Lutheran sent 24 representatives. Wow, it was an amazing trip. The second was a 39 hour Twin Cities Adventure with Our Saviors in Moorhead for 7th-12th graders where we did service projects and had fun too. I also visited our campers while they were at Camp Emmaus.

My Glyndon/DGF hat is one that I wear with pride. I love being part of our community. I got to emcee Glyndon Family Fun Day! I also got to attend many events; Glyndon Days festivities, Middle School and High School games/meets, band and choir concerts, Donkey Ball, Prom, and High School graduation (and Open Houses).

In 2014, the partnership that Glyndon Lutheran has with the Synod remained at 1/4 time. My Synod hat has continued to be primarily planning and executing the Synod's Youth Gatherings. 2014's Synod Gatherings were the best to date. I was in charge of the youth delegates at the Synod Assembly in May. I continue to be the NWMN Synod's Practice Discipleship Coach; I led workshops and trainings around the Synod on the state of the Church and how to be affective given the ever changing demographic of the Church. With that particular hat, I organized a Practice Discipleship Retreat for Region 3 (MN, ND, SD) at Luther Crest Bible Camp. I am the NWMN Synod's National Gathering Coordinator for the Gathering that will be in Detroit, MI in July of 2015, I attended a training in Chicago in April. I took to two youth delegates from the LYO Board of the

Synod to Detroit in November for the ELCA Youth Leadership Summit. I also became active in the SYMBOL (Synodical Youth Ministry Band Of Leaders) Network being the Chair of the Region 3 Steering Committee, helping to organize the Annual Gathering, and attended a Continuing Education event in Detroit in August.

The hat I added last year was being accepted into Candidacy to become a Diaconal Minister in the ELCA; which means that I passed extensive background checks, psyche evaluations, and my Entrance interview. I will have some things to work on in 2015; continue to meet with a Spiritual Director and writing more essays along with some other things as well. Thank you for your support in this "certification process".

I am looking forward to the many adventures my various hats will lead me though in 2015 as we "do" ministry together.

Properties Board Report

Projects at GLC:

- Remodeled 2 bathrooms in Narthex. Removed wallpaper, taped walls, & painted. New light fixtures & installed hot water hear for both bathrooms. Put in new sink & faucets in women's bathroom, put in new faucet in men's.
- 2 stain glass windows repaired & releaded. Put on thermos glass on 4 stain glass exterior windows. All 6 stain glass windows are done with repairs.
- Removed vestibule on NW education wing. Pour new concrete floor & sidewalks. Rebuilt the vestibule
 with wood frame & sheeting. Installed steel siding. Reused existing window & door. Replaced glass in
 doors.
- Caulked around the west side of church where cement wall & siding meet.
- Put sound panels on basement walls.
- Got estimate on parking lot for drain tile. Approved to do the job. Drain tile installed & backfilled.
- Bruce Ellingson & LeRoy Babolian met with Ruseo window, got estimate to replace all windows in Education wing. \$12,000
- Cleaned the west stairway landing to kitchen. Has snow and water coming in.
- Rain gutter need repair. Ends are damaged in by what appears to be run over by lawn mower.
 Checked rain gutter on west side. Fascia is rotten out. Got estimate to repair fascia & replaced.
 Repaired all rain gutters that are damaged.
- Fascia board & metal cap are done. Waiting for rain gutter to be completed.
- Fischer's Tree Removal removed 2 ash trees on west side of GLC by the entrance. Bruce & LeRoy helped. LeRoy hauled the wood to his wood pile.
- Bruce & LeRoy removed rock around church. The tree stumps were removed, and we removed the wood chip and back filled dirt. Planted grass seed, & watered daily.
- Put in church banner to advertise for the Glyndon Days Parade.
- Bruce, Esther, and LeRoy moped up water in basement several times from too much rain & plugged rain gutter. Bruce & I cleaned rain gutters.
- Oiled & tighten screw in door hinges throughout the exterior & interior doors.
- Fixed the organ bench for Jean Hellner, our Organist.
- Bruce installed door sweeps on door that needed repair.
- Removed paint off doors in education wing, and 1 sound panel that still has paint stains on it.
- Complaints about basement is too cold. Checked out furnace. 1 furnace hasn't worked in at least 3 yr. Motor was burnt out. Filter & board was replaced and furnace is working.
- Christmas tree was put up & taken down by Bruce, Esther, and LeRoy.
- Removed carpet & scraped floor in Jean Hellner's office. Need to reinstall new carpet. Purchased new carpet. Need to contact an installer.

New Life Center Auxiliary

Mission Statement: We are a community of caring people who have been meeting needs and transforming lives through the love of Christ since 1907. We help people who are homeless and hurting discover value and find hope. Our aim is to help them go from merely surviving to truly thriving.

Darlene Sandal and Pat Hemmah are the representatives for Glyndon Lutheran Church to the New Life Center auxiliary (NLC). We meet at area churches once a month for a noon luncheon, business meeting, and program. A major fundraiser for the auxiliary is the Prayer Breakfast held each spring. Several hundred area women attend this event.

The auxiliary provides the following items for the men at the NLC during the year: sheets, pillows, blankets, towels, coffee, canned goods, clothing items, pumpkin pies for their Thanksgiving dinner, Christmas cookies, etc. As you can see, there is a dire need for the auxiliary.

Our church is asked to donate items of clothing (socks, thermal underwear, gloves, and stocking hates) during December to be given as Christmas presents for the residents.

During 2014 (through Dec. 15) the NLC provided 30,023 nights of lodging (nightly average is 84 persons). They have 87 emergency beds plus 18 in-house overflow beds. In-house overflow beds are proved from mid-October to mid-April. Total meals served were 89,703 with a daily average of 257.

The number of volunteers for the above listed time frame was 813 and number of volunteer hours was 2,532.

If anyone is interested in becoming a member of the auxiliary, please contact Darlene or myself. You are more than welcome to attend a meeting with us to "test the waters".
