George Bithos, Texas Conference of Churches; and the facilitators.

Credentials Committee Report 1

Darrell Reimer, chair, reported that at 2:49 pm, there were 287 voting members registered, of which 79 were male clergy, 18 were female clergy, 114 male lay members; 76 female lay members. The voting composition of the assembly was 66.20 percent laity and 33:80 percent clergy. There were 62 visitors registered.

WHEREAS, the Anti-Defamation League has been a leader in bringing together people of different religions and cultures by creating the inter-religious "Coalition for Mutual Respect" where pulpit and educational exchanges can take place among people of diverse backgrounds in order to learn to know and respect one another; and

WHEREAS, many ELCA congregations, other Christian denominations, and other religious groups in our TX-LA Gulf Coast Synod area have been a part of the Coalition for Mutual Respect's pulpit and educational exchange over recent years; and

WHEREAS, the well being of our communities depends on religious communities coming together publicly to show solidarity and commitment toward peace and respect: now, therefore be it

RESOLVED, that the TX-LA Gulf Coast Synod join the Anti-Defamation League's "Coalition for Mutual Respect" by declaring that this synod is a "Community of Respect"; and, be it further

RESOLUTION NUMBER FOURTEEN

A Resolution to the ELCA Churchwide Assembly to Update the Social Statement on "Caring for Creation: Vision and Hope"

WHEREAS, God created the COSMOS out of love and commanded us to be stewards of it; and humans have added enough carbon dioxide and other gases to the atmosphere to affect the climate, increase the earth's temperature. Modify weather patterns and melt glaciers, which could cause the loss of full one-third of plant and animal species and cause more storms, flooding, and rising sea levels that will displace and impoverish hundreds of millions it not billions of humans, thus, failing to fulfill God's commandments to be good stewards of the earth and harming or destroying much of the flora and fauna which God has created; and WHEREAS, the Social Statement on *Caring for Creation: Vision and Hope*, adopted by the ELCA in its 1993 churchwide assembly

- Recognized our developing environmental crisis;
- Acknowledged humanity's separation from God and from the rest of creation as the central cause of the environmental crisis;
- Provided a theological rationale for caring for God's creation, including a vision of God's intention for creation and humanity as creation's caregivers; and
- Expressed hope, calling the ELCA to effective, responsive action for environmental Integrity; and

WHEREAS, the ELCA strives to honor God's laws but wrote its major statement on environmental policy in 1993, a document which, although it includes limited references to the effect of global warming on creation focuses on the environmental impact of toxic pollution, and approved another less public paper policy in 2003 discussing global warming and actions to prevent it; and

WHEREAS, we believe that it is now time for the ELCA to take an even more proactive stance On how we will fulfill God's first directive;

THEREFORE, BE IT RESOLVED that the TX-LA Gulf Coast Synod memorialize to the 2007 Churchwide Assembly to call for a revision of the social statement *Caring for Creation; Vision and Hope* to develop an expanded statement of environmental policy which

- A. Addresses all if humanity's impacts on the environment;
- B Encourages individuals and congregations to work with local, regional and national governments to promote sustainable environmental practices and policies;
- C. Encourages individuals and congregations to seek ways to reduce environmental resource consumption by adopting an *"environmental tithe"* which would include reducing energy usage and waste generation (paper, plastics, glass, ink, etc.) by at least 10%;
- D. and since encouragement is often not enough, calls for the ELCA, its offices and its churchwide staff, its schools, organizations and agencies to be *models* for its synods and congregations by:
 - 1. Working diligently to lessen its/their personal and corporate impacts on on global warming (carbon footprint) by reducing its amount of carbon dioxide and other global warming gases which their actions generate,
 - 2. Calculating and progressively increasing their energy conversation and consumption, for example, by performing an energy audit, by recycling,

and by evaluating their procurement policies and their resourceconsumption reduction;

- 3. Incorporating incentives into the Mission Investment Fund that encourage environmentally responsible design, construction and siting of new congregations and rebuilding (in the wake of natural disasters) in ways that is environmentally appropriate;
- 4. Modeling environment responsibility at all national assemblies and Gatherings by recycling and conserving energy;
- 5. Promoting investment by the ELCA pension funds, benevolent societies and individual members in corporations or organizations which develop alternative energy generation, for example, investments in wind energy or biogas from livestock wastes would especially help Lutheran farming communities and materially affect our need to use fossil fuels.

FURTHERMORE, BE IT IS ALSO RESOLVED that the TX-LA Gulf Coast Synod

- 1. Encourage its individual congregations and members to become more aware of their impact on the environment and to work with our neighbors to enhance rather than degrade God's creation; and
- 2. Be a model for its congregations by promoting D 1 thru 5 above.

The Reference and Counsel Committee dealt with Resolutions 4-10 by banding 4 and 8 with 4 remaining; to band 5 and 9 with 5 remaining; and to band 6 and 10 with 6 remaining (rationale: similar topics and wording.) The remaining Resolutions 5, 6, and 7 were treated as a group. The Reference and Counsel Committee recommended they not be adopted.

RESOLUTION NUMBER TWO

A Resolution to Memorialize the ELCA to Change the Policy of Lutheran Disaster Response **WHEREAS**, the current policy and/or practices of the Lutheran Disaster Response (LDR) does not allow money contributed to LDR to be used for the rebuilding of churches devastated by disaster; and

WHEREAS, that policy forces congregations to hustle and scramble in search of alternative financial assistance for their rebuilding; and

WHEREAS, many contributors to LDR naturally assume that their donations will also be used for the rebuilding of Lutheran churches; and

WHEREAS, current policy and/or practice often leads pastors and congregations to be preoccupied with finding the financial resources to rebuild their structures, diverting time, effort, and money away fro the other ministries of the congregations; and

WHEREAS, the current policy and/or practice has caused bewilderment, outrage, and resentment among members of devastated church and has caused a PR blunder for LDR in recently ravaged areas; and

WHEREAS, it is the local congregation which provides hope, compassion, and physical help to it community, and therefore needs immediate support following a disaster

THEREFORE, BE IT RESOLVED that the TX-LA Gulf Coast Synod, meeting Assembly, memorialize the ELCA Churchwide Assembly to change its practice and policy immediately in order to free up both current and future donations to Lutheran Disaster Response for us in the rebuilding of church facilities affected by disaster. ADOPTED

RESOLUTION NUMBER THIRTEEN

A Resolution to the ELCA Churchwide Assembly to Immediately Create a Roster of Retired Pastors Who Are Willing to Be Called to Serve as Interim

Pastors, or to Provide Pulpit Relief, in Congregations in Disaster-Stricken Areas **WHEREAS**, in the wake of Hurricanes Katrina and Rita, the financial, emotional, and spiritual burdens on congregations afflicted by disaster have increased enormously; and

WHEREAS, a number of congregations in the Texas-Louisiana Gulf Coast Synod have been unable to call pastoral staff and to lead them because of the uncertainty of their circumstances in the wake of Hurricanes; and

WHEREAS, the finances of some disaster-stricken congregations have been so devastated that they are unable to adequately compensate their pastors in order that they can continue in their communities where they have bee called to serve; and

WHEREAS, the pastoral staffs of other congregations have been severely taxed as a result of their responsibility not merely to lead their own congregations, but to assist in the support and rebuilding of other congregations destroyed – or placed at risk – by the hurricanes and their aftermath; and

WHEREAS, there is a need for an intentional commitment on the part of the national church to provide additional ordained leadership in times of crisis in order to assist those churches in need of pastoral staff and to provide relief to those pastors who have struggled without respite since their disasters

THEREFORE, BE IT RESOLVED that the Texas-Louisiana Gulf Coast Synod memorialize the 2007 Churchwide Assembly to request that:

- 1. the Presiding Bishop promptly undertake to identify and create a list of retired, rostered clergy and chaplains who are willing to serve in disaster-stricken areas as intentional, interim pastoral staff in disaster-stricken communities and congregations that need additional help; and
- 2. the Evangelical Lutheran Church in America provide resources sufficient to fund the amounts necessary to pay interim and permanent pastoral staff salaries (if local congregations lack the means to do so) in order to permit rostered clergy and chaplains to return to the service of the church in disaster-stricken areas, ADOPTED

RESOLUTION NUMBER FIFTEEN

A Resolution to Develop and ELCA Response Plan to Assist

Clergy and Congregations Impacted by Disaster

WHEREAS, Hurricanes Katrina and Rita taught many valuable lessons to be learned about disaster response; and

WHEREAS, the faith communities of the Gulf Coast areas, the ELCA, and the world responded with great generosity and love; and

WHEREAS, the presence of local pastors and congregations became beacons of hope and visible signs of Christ in the midst of devastation; and

WHEREAS, the local congregations and their church facilities should be spiritual centers in the relief response, and long-term recovery efforts as well as a public witness to the core values of Lutheran communities; and

WHEREAS, Lutheran Disaster Response does not allocate money to the financial support of pastors and staff, rebuilding church buildings. Or congregational ministries devastated by disaster; and

WHEREAS, the gap of coverage for and their staff impacted by a disaster is one of the lessons learned from Hurricanes Katrina and Rita as well as other disasters which have hit our country; THEREFORE, BE IT RESOLVED that the TX-LA Gulf Coast Synod, meeting Assembly, memorialize the Evangelical Lutheran Church in America Churchwide Assembly to instruct the Evangelical Outreach and Congregational Mission unit of the ELCA to develop a clear,

immediate, and effective response plan to assist local pastors and congregations in disaster areas. ADOPTED

RESOLUTION NUMBER FIVE

A Memorial to Encourage Refraining from Discipline

WHEREAS, there is currently no consensus in this church regarding the rostered service of persons in committed same-gender relationships (Report of the Task Force for ELCA Studies on Sexuality, p. 5);and

BE IT FURTHER RESOLVED that synods, synodical bishops, and the Presiding Bishop of this church are encouraged to refrain from disciplining those rostered leaders in a mutual, chaste, and faithful committed same-gender relationship who have been thus called, approved, ordained, commissioned, or consecrated.

A Resolution to Request that the Bishop of the Texas-Louisiana Gulf Coast Synod Institute a Mission Partnership Between Churches In the Western Half of the Synod and Congregations

Affected by Hurricanes Katrina and Rita

WHEREAS, in the wake of Hurricanes Katrina and Rita, the financial, emotional, and spiritual burdens on congregations afflicted by disaster have placed them under significant strain; and WHEREAS, many members of congregations outside the areas affected by the hurricanes are unaware of the continuing plight of the congregations affected by them; and WHEREAS, many in the communities affected by the hurricanes feel their needs have been forgotten by the nation, by the church at large, and by their brothers and sisters in Christ; and WHEREAS, congregations outside the Eastern half of the Synod are called to reach out in love to their brothers and sisters in other congregations; and

WHEREAS, God, through the Holy Spirit, has given all of us a new mission field where the Harvest is plenty but the workers are few; now

THEREFORE, BE IT RESOLVED, that the Bishop of the Texas-Louisiana Gulf Coast Synod implement a "mission Partnership" in which congregations affected by Hurricanes Rita and Katrina are partnered with congregations in the Western half of the Synod for the purpose of:

1, A shared, and specific, ministry of mutual prayer for one another;

2. Exploring ways in which partnered congregations may undertake joint service or educational projects for the purpose of strengthening their ties of fellowship and Christian love for one another;

 Reviving apostolic correspondence between them, so that the sharing of good news and ministry successes (and needs) by one will serve to encourage and uplift the other:
 Supporting, including through financial support, of each other's mission and ministry Priorities through their emergence from this crisis; and

5. Other activities (such as a program of regular visitation by members of partnered congregations) designed to impress upon hurricane-stricken congregations that they are not alone in their struggles, and that their brothers and sisters in Christ have not forgotten them, but, instead, have heard their plea and intend to answer their cries for help, comfort and consolation.

THEREFORE, BE IT RESOLVED, that the Synod Council give priority to establishing structures, means and methods to identify and gather significant financial resources necessary to maintain and extend the ministry of the Texas-Louisiana Gulf Coast Synod, permitting the acquisition of land and the construction of new facilities for congregational starts and restarts; and **BE IT FURTHER RESOLVED,** that one strategy to be considered is the establishment of a "New Start/Restart Fund" in each congregation to be available to assist with the costs of

"New Start/Restart Fund" in each congregation to be available to assist with the costs of purchasing land or facilities for new starts and restarts at specific times for specific ministries.
