**Credentials Committee Report #1**

Darrell Reimer, chair, reported that at 3:38 p.m., there 295 voting members registered, of which 80 were male clergy, 22 were female clergy, 68 male lay voting members, and 125 were female voting members. The voting composition of the assembly was 65.42 percent laity and 34.58 percent clergy. There were 42 visitors registered.

SA06.06.04 that S7.26. of the Constitution of the Texas-Louisiana Gulf Coast Synod be amended to read: S7.26. This synod may establish processes through the Synod Council that permit representatives of mission settings formed with the intent of becoming chartered congregations and authorized worshiping communities of the synod, which have been authorized under ELCA bylaw 10.02.03., to serve as voting members of the Synod Assembly, consistent with †S7.21. Authorized worshiping communities, acknowledged under criteria, policies, and procedures by the Church Council of the Evangelical Lutheran Church in America shall accept and adhere to the Confession of Faith and the Statement of Purpose of this church, shall be served by leadership under the criteria of the church and shall be subject to the discipline of this church. ADOPTED

SA06.06.06 to adopt Resolution #1 "Serving the Poor/Reducing Poverty Factors" submitted by Ben Powell, a member of Living Word, Katy, Texas, with amendment by adding words "Gulf Coast Synod" in the Resolved paragraph following the words "Texas-Louisiana". ADOPTED

The adopted Resolution reads:

WHEREAS, Members, congregations of the Texas-Louisiana Gulf Coast Synod have a history of serving those in need with food, housing repairs, and social services are committed to reducing the level of poverty in our area and in the world,

WHEREAS, Thrivent Financial for Lutherans has committed \$105M over the next four years to work with Habitat for Humanity, International (HFHI) to reduce poverty housing in the US and globally through ThriventBuilds,

WHEREAS, Members and congregations throughout the Synod have been active with local HFHI affiliates to improve housing in their communities,

WHEREAS, The ELCA has been involved with the ONE campaign to reduce poverty. HFHI and ThriventBuilds have a similar commitment to the ONE campaign with a focus on reducing poverty housing.

WHEREAS, ThriventBuilds will build six homes in Houston, one in Baton Rouge in 2006, and has committed \$5M to rebuild and add housing in the area affected by Katrina,

THEREFORE BE IT RESOLVED that the Texas-Louisiana Gulf Coast Synod embraces ThriventBuilds and Habitat for Humanity, International as a way to make significant progress in minimizing poverty housing in our area and in the world. We encourage any and all members with a passion to improve housing to participate in the ministry to those who need a "hand up."

SA06.06.07 to adopt Resolution #3 "Millennium Development Goals/ONE Lutheran Campaign" submitted by Beverly Davis, a member of synod Global Mission Team and Christ the King Lutheran Church, Houston, Texas, as presented. ADOPTED

The adopted Resolution reads:

WHEREAS, "Stepping forward as a public Church" is one of the five strategic directions for this Church and advocacy ministry is central to this direction,

WHEREAS, the ELCA Churchwide Assembly passed a resolution declaring ending hunger to be a core mission of the Church,

WHEREAS, the Scriptures declare thematically God's concern for the poor and oppressed, and describe the ministry of Jesus as "good news for the poor", and specify the content of Jesus' judgment as our acts on behalf of "the least of these",

WHEREAS, Lutheran theology sees in government structures the potential for a blessed and instrumental purpose,

WHEREAS, on behalf of the ELCA, Presiding Bishop Hanson endorsed the ONE Campaign to fight extreme poverty and global HIV/AIDS in 2005; and the ELCA Conference of Bishops identified the ONED Lutheran Campaign as one of the three priorities for the 2006 calendar year,

WHEREAS, the ELCA social statement on economic life, "*Sufficient, Sustainable Livelihood for All*," calls us to "scrutiny of how specific policies and practices affect people and nations that are the poorest, and changes to make policies of economic growth, trade, and investment more beneficial to those who are poor,"

WHEREAS, "*Sufficient, Sustainable Livelihood for All*" also calls for "support for family planning and enhanced opportunities for women so that population might be eased," (6)

WHEREAS, The ELCA social statement "*For Peace in God's World*" affirms that "our nation has responsibility to contribute a portion of its wealth to people in poorer nations through effective

economic assistance,” and that the purpose of such assistance “should be to reduce hunger and poverty in sustainable and environmentally sound ways,” (16)

WHEREAS, “*For Peace in God’s World*” also acknowledges that ““While the United States has been generous in providing humanitarian aid, our nation dramatically trails the rest of the industrialized world in providing development assistance relative to our production of wealth,” (16)

BE IT THEREFORE RESOLVED that the Texas-Louisiana Gulf Coast Synod and its congregations shall urge elected representatives to support increases in effective poverty-focused development assistance in order to meet the Millennium Development Goals (MDGs),

BE IT FURTHER RESOLVED that synod congregations commit to studying the MDGs in order to deepen their understanding of the complex issues of poverty that must be addressed in order to achieve the goals of the ONE Campaign,

BE IT FURTHER RESOLVED that synod congregations shall be encouraged to become ONE Lutheran congregations and to speak publicly on behalf of the ONE Campaign, and

BE IT FURTHER RESOLVED that synod congregations shall be encouraged to understand the relationship between our activities with the World Hunger Appeal, Stand With Africa, and other ELCA hunger and poverty related efforts.

**Staff/Budget Report**

Bishop Blom reminded the Assembly members that we are The TELLing Synod:

T=Transformational; E= Evangelical; L=Leadership; and L=Lutheran people.

The past year was dominated by response to the effects of Hurricanes Katrina and Rita – (energy and time of staff consumed; great ELCA response 1.3 million dollars to help support leaders and families concern for emotional and spiritual needs of leaders.)

Members of the Office of Bishop Management Team made presentations concerning the scope of their work: (Dave Morrell – Call Process; George Bement – Leadership; Peggy Contos Hahn and Rozella White – partnership for youth and family ministry; Rob Moore's 7<sup>th</sup> report featured a video "Faith in the midst of the Storm" prepared by Pr. John McCullough Bade and a Partners in Mission video "What Are You Called to Do?")

The Synod Council has appointed a Transition Team for the coming "Year of Transition" One of the questions to be considered by synod members is "What is the mission of Synod in next 6 years?" What gifts of leadership will be needed to fulfill that mission? Bishop Blom asked the assembly members to practice for 5 minutes how to discuss things together. The test question was "What role should this synod have as its mission in responding to the stranger, the immigrant?"

**Motion:** David Hollrah, chair moved the adoption of Resolution #2 “Synodical Leadership Position for Lutheran Men in Mission” presented by Pr. Brian Gige of New Life Lutheran Church in Pearland.

SA06.06.10. to adopt Resolution #2 as amended by the Reference and Counsel Committee. ADOPTED. The amended Resolution # 2 as adopted reads:  
WHEREAS, the largest nonchurched population in the USA is young men ages 19-35, and  
WHEREAS, the ELCA's Lutheran Men in Mission (LMM) is reaching out to these young men through local congregational, synodical and regional events, and  
WHEREAS, ELCA leaders such as Dr. Rollie Martinson, Dr. Paul Hill and others by their efforts continue the strengthening of our youth networks encouraging a continued outreach to this male population and as this population continues to age, and  
WHEREAS, current finding indicate that part of the strength of any 21<sup>st</sup> century congregation is reflected the strength of its local men's ministry, and  
WHEREAS, Gulf Coast Synod congregations seek to strength their ministry efforts to this population, and  
WHEREAS, the Gulf Coast Synod currently maintains synod level position for the Call Process, Leadership, Multi-cultural ministry, etc, and  
WHEREAS, there is no current position at the synod level designated for oversight for ministry to men, and  
WHEREAS, there is a genuine need for the development and strengthening of a synodical network for men's ministry,  
BE IT RESOLVED that the 2006 Assembly of the TX-LA Gulf Coast Synod direct the Synod Council through the Management Team, to create a leadership position for men's ministry in the synod under the oversight of the Youth and Family ministry, and  
BE IT FURTHER RESOLVED that this position be filled with the utmost sense of urgency.

**Motion:** David Hollrah, chair moved the adoption of Resolution #4 “Resolution to Empower the Texas Louisiana Gulf Coast Synod to Engage the Synod and its Churches with Immigrant and Refugee issues” presented by John C. Wenger and Susan Giesecke without amendment.

SA06.06.11. to adopt Resolution #4 as presented. ADOPTED

The adopted Resolution reads:

WHEREAS, the ELCA Churchwide Assembly voted to welcome and encourage task forces in our synods to “empower this church in its engagement with refugee and immigrant issues;  
WHEREAS, it is consistent with the teachings of Jesus and the Bible that the Church and its members offer aid and assistance to those who are in need of such, including refugees and immigrants;

WHEREAS, the needs and conditions of refugees and immigrants are topics that the Synod and its Churches could educate its members about in the context of the teachings of Jesus;  
WHEREAS, members of this Synod should be encouraged to address the issues surrounding immigrations based upon the application of the teachings of Jesus,  
NOW THEREFORE BE IT RESOLVED BY THIS SYNOD THAT:

1. At the direction of the Bishop, the Synod constitute and organize an Immigration and Refugee Task Force composed of members of this Synod;
2. The Task Force be charged with developing a program to educate Congregations in this Synod about the conditions of immigrants in our synod and nation, the various approaches to immigration being advocated by lawmakers, the needs of immigrants in our communities and how our Synod can help immigrants and refugees address these needs,
3. The Task Force shall make specific recommendation to the Bishop for the Synod to assist immigrants and refugees in this Synod.
4. The Task Force shall seek advice and assistance from Lutheran Immigration and Refugee Service in performing its duties.

The Assembly was recessed until Saturday morning at 8:00 a.m.
